## **AFFILIATE PROGRAM COMMISSION CHANGES**

### **Current Program**

### Beginning June 22, 2024

- 0% for Affiliate enrollments

### **AFFILIATE TRANSITION**

#### **AFFILIATE COMMISSION**

Existing Affiliates will earn a flat 15% commission on all product sales made to new Preferred Customers or retail customers who enroll **after** June 22, 2024. 50% of the volume will roll on these orders.


Any Preferred Customers they enrolled <u>**before</u>** June 22 will continue to generate the 15–20% commission. 40% of the volume will roll on these orders.</u>

### **AFFILIATE ORDER BONUS**

Associates and Affiliates will earn a 10% order bonus on personal purchases made by <u>NEW</u> personally sponsored Affiliates. 70% of the volume will roll on these orders. Affiliates who enrolled before June 22, 2024 will continue to roll 100% of the volume on their personal purchases.







# SALES REQUIREMENT

All Affiliates must generate at least **\$150 USD** in customer sales every 60 days to maintain their status as an Affiliate. Personal purchases do not count toward this sales requirement. If an Affiliate does not meet these sales requirements, they will be automatically reclassified as a Preferred Customer.

Affiliates who are reclassified as a Preferred Customer will still enjoy all the same discounts and purchasing benefits they received as an Affiliate, but rather than earning Affiliate commissions and referral rewards, they will participate in our Refer a Friend program where they earn product credits to use toward future purchases if they still want to share products casually.
